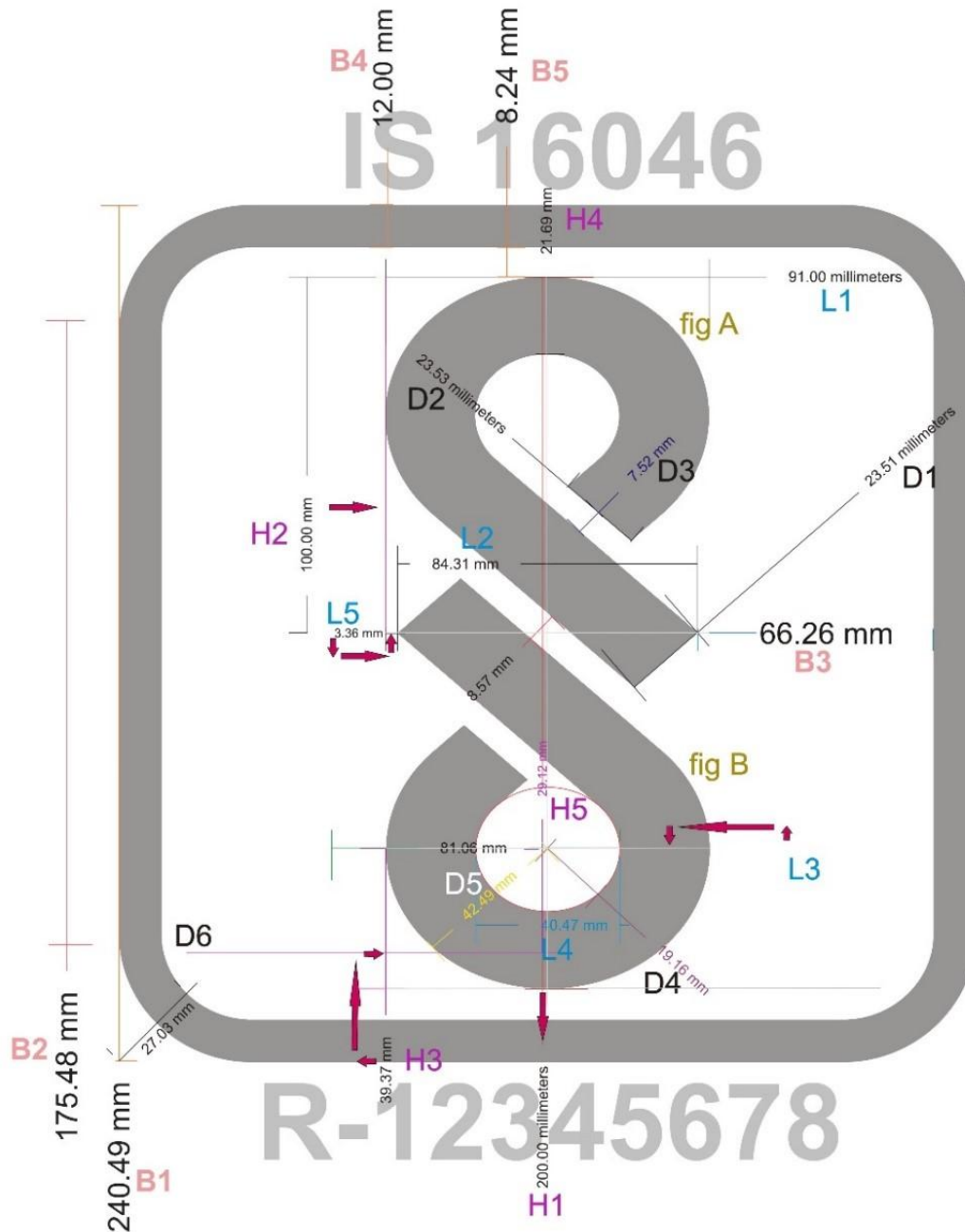

Further, the durability of marking shall be as per the provisions of the relevant Indian Standard, wherever applicable. The diplay of IS number, Registration number and words shall not be less than Arial forn size 6.
- iv) Any device with a integrated display sceen may present the Standard Mark electronically (e-labelling) in lieu of a physical presentation on the product.
